# MINUTES OF OCTOBER 9, 2019 <br> REGULAR MEETING OF THE <br> MEDWAY HOUSING AUTHORITY 

The Medway Housing Authority held its Regular Meeting on Wednesday, October 9, 2019 at the Conference Room at Mahan Circle, Medway, Massachusetts. The following members were in attendance: Mr. Rice, Ms. Larrabee and Mr. Coyle. Executive Director Hayley Fetrow, Assistant Director Sheila Souza, Selectwoman Maryjane White, and Susy Affleck-Childs, Planning and Economic Development Coordinator for the Town of Medway were also in attendance.

Chairman Rice called the meeting to order at 12:30 p.m. Upon the motion of Chairman Rice and seconded by Ms. Larrabee, the Board voted to suspend the Agenda and move Item 4. A. Oak Grove Zoning Presentation to the first order or business.

Chairman Rice welcomed Ms. Affleck-Childs to the meeting. Ms. AffleckChilds gave a power point presentation on the new proposed zoning for the redevelopment of the Oak Grove Urban Renewal Area (Bottle Cap Lots). She explained that the Community and Development Board is showing the presentation to all Town Boards and Committees to make them aware of new zoning bylaws. The Board thanked Ms. Affleck-Childs for the informative presentation and she left the meeting.

Chairman Rice asked the members if there were any changes in the minutes that were emailed to them. There being no changes, the minutes of the September 11, 2019 Regular Meeting were approved upon the motion of Ms. Larrabee and seconded by Mr. Coyle.

The new State Appointed Board Member Andrea McCarthy joined the meeting by phone.

a. Vacancies - Maintenance is working on 302 Mahan Circle, 115 Maple Lane, and 15 Kenney Drive. Next month 8C Kenney Drive and 51 Lovering Heights will be renovated.
b. Executive Director Report - E.D. Fetrow reviewed the Administration, September 2019 Financial statements, Tenants Accounts Receivable, Maintenance and Capital Items with the Board.

a. DHCD Resident Services Coordinator Grant - Upon the motion of Ms. Larrabee and seconded by Mr. Coyle, the Board unanimously voted to approve the Executive Director to submit the application for a state-aided Resident Services Coordinator grant per PHN 2019-19, Notice of Funding Availability - Resident Services Coordinators.
b. Notices (available for review) - E.D. Fetrow reviewed the current DHCD Public Housing Notices with the Board.
c. Executive Session - At 1:15 p.m. Mr. Coyle moved that the Board enter Executive Session for the purposes of personnel and Executive Director Search. Ms. Larrabee seconded, and it was so voted by roll call:
